Reference is invited to this branch circulars dated 25.02.2026 bearing number F.No. 3/CM SHRI/Admission/2025-26/563, circular dated 06.03.2026 bearing number F. No.3/CM SHRI/Admission/2025-26/585, and circular bearing number F. No.3/CM SHRI/Admission/2025-26/343461/610 dated 06.04.2026, wherein guidelines were issued for the conduct of the admission test for Classes VI, IX and XI in CM SHRI Schools for the academic session 2026–27.

The Admission Test 2026 was held for Classes 6 and 9 on April 13, 2026, at 75 test centres across Delhi. Candidates can view their results on April 30 (12 noon onwards), along with their scores and respective cutoffs, by logging in with their Roll Number and Date of Birth on the official website of DoE : [**edudel.nic.in**](http://edudel.nic.in)

The number of candidates shortlisted for the second round of Admission Test in SBS CM SHRI School, Jharoda Kalan (Residential School), for both Classes 6 and 9, is approximately three times of the number of available seats.

The allocation of schools has been done as per candidate rank, preferences, and proximity norms under the RTE Act. Minimum Qualifying marks used for preparation of merit list is as follows:

Class 6	60 marks for UR category	45 marks for other categories
Class 9	60 marks for UR category	40 marks for other categories

Candidates are hereby instructed to report immediately to the schools allotted to them for completing admission formalities, as per the following schedule:

Reporting Date	02.05.2026 – 07.05.2026
Reporting Time	8.30 AM onwards (For General/Morning Shift Schools) 2:00 PM onwards (For Evening Shift Schools)

The last date for reporting for admission shall be **07.05.2026**. After this date, any unfilled seat will be treated as vacant, and admission will be offered to the next candidate on the waiting list. No selected candidate shall have any claim to admission after the last date of reporting.

Further, in continuation of the public notice dated 06.04.2026, it is hereby informed the **schedule of the Admission Test for Class 11** is as follows:
