SUB: CANCELLATION/REJECTION OF CANDIDATURE OF SHRI MANOJ BARANWAL, ROLL NO. 2690011182, DOB – 01.06.1988, CATEGORY-UR FOR THE POST OF TGT SANSKRIT (MALE) POST CODE-144/17

Whereas, Shri Manoj Baranwal, Roll No. 2690011182, DoB – 01.06.1988, Category-UR was provisionally selected vide Supplementary Result Notice No. 964 dated 19.02.2025 and e dossiers to the post of TGT Sanskrit Male (Post Code 144/17) forwarded by DSSSB in compliance of the Hon'ble Supreme Court Order dated 11.11.2024 in SLP(Civil) Diary No. 32786/2024, Hon'ble High Court Order dated 01.03.2024 in WP (C) No. 10193 / 2019 and Learned CAT Order dated 13.05.2019 in OA No. 892/2019 in the matter of GNCT of Delhi & Ors. V/s Jitender Kaushik.

And whereas, offer of appointment dated 21.07.2025 was issued for his personal appearance for documents verification, but Shri Manoj Baranwal remained absent on that day. A Reminder dated 22.08.2025 was issued for documents verification on 03.09.2025, but Shri Manoj Baranwal again remained absent on that day and appears on 08.09.2025. Documents Verification has been done on 08.09.2025.

And whereas, during the documents verification, deficiencies were being found and a deficiency memo dated 08.09.2025 and reminder dated 14.10.2025 was issued to the Shri Mukesh Baranwal by this office with the direction to submit the reply within 15 days and 10 days.

And whereas, in response to deficiency memo, reply dated 15.09.2025 and 14.10.2025 has been received in this office vide which Shri Manoj Baranwal seeks more time i.e. 03 months for submission of requisite documents.

And whereas, after the approval of worthy Director (Education), extension was given to the candidate vide letter dated 27.11.2025 and 19.12.2025, but no reply/documents has been received in this from the candidate, Shri Manoj Baranwal till date.

And whereas, the matter in detail along with relevant documents have been placed before Competent Authority and it has been approved for rejecting/cancelling the candidature of Shri Manoj Baranwal, Roll No. 2690011182, DoB – 01.06.1988, Category-UR for the post of TGT Sanskrit Male, Post Code 144/17.

Therefore, keeping in view of the above facts & circumstances, the offer of appointment dated 21.07.2025 and Reminder dated 22.08.2025 issued to Shri Manoj Baranwal, Roll No. 2690011182, DoB – 01.06.1988, Category-UR is hereby withdrawn from retrospective date and his candidature is hereby stand cancelled/rejected for the post of TGT Sanskrit Male, Post Code 144/17 and dossier is being returned to DSSSB for further necessary action at their end.

"No claim for appointment, if so, made at any later stage on the basis of any ground by the candidate, will be entertained by the department, in future."
