ORDER

Cancellation of candidature for the post of TGT (Social Science) Female, Post Code 40/21

Whereas, **Ms. Saunam Meena** (Employee ID - 20251132), D.O.B. – 15.05.1995 has been nominated by the DSSSB for the post of TGT (Social Science) Female under the post code of 40/21 vide letter No. F.No.4 (612)/DSSSB/CC-I/2021/1049-1055 dated 02.08.2022 (as per vacancy advertisement: No. 02/21) by the Selection Mechanism Authority i.e. DSSSB vide result notice No. 261 dated 18.12.2024 and after completion of further course of document verification on the scheduled date and time given in offer of appointment letter and medical examination thereafter. Accordingly, the said candidate was provisionally appointed under provisions of FR-10 and appointment letter was issued.

Whereas, as per Appointment Order issued vide no. F. No.DE.3(34)/DRC/E-III/TGT (Social Science)/Female/2022/1936-47 dated 03/11/2025, **Ms. Saunam Meena** was required to join the place of posting by 02/12/2025. In continuation of appointment letter, extension of joining was also issued to **Ms. Saunam Meena** vide letter dated 22/12/2025 and last date of joining was further extended to 02/02/2026. However, **Ms. Saunam Meena** did not join the place of posting by the given time and a final opportunity memo was issued to the said candidate vide no. F. No.DE.3(34)/DRC/E-III/TGT (Social Science)/Female/Extension/2025/75 dated 18.03.2026 and also put in the public domain with the direction to join the duty within stipulated time mentioned in the final opportunity. The joining time has already been expired and candidate fail to join despite of given ample time.

Whereas, neither she joined the duty/present physically before the Competent Authority nor any written request/representation for extension of joining time was received by this office i.e. DR Cell E-III, Directorate of Education in this regard. Hence, it is concluded that the above said candidate is not interested to join the duty and has not reported by now.

As per DoPT Office Memorandum No. 35016/2/93/Estt.(D) dated 09/08/1995 referred para 2, the following has been mentioned.

"An Offer of appointment should clearly specify the period after which the offer would lapse automatically if the candidate did not join within the specified period. If, however within the specified period a request is received from the candidate for extension of time, it may be considered by the ministry/department but extension beyond 3 months should not be granted liberally. "



In view of the above facts & circumstances, as stated above and since the candidate has wilfully chosen not to respond to the memorandum, this tantamount to refusal to accept offer of appointment. Therefore, the candidature in r/o **Ms. Saunam Meena** is hereby cancelled and dossier is returned to DSSSB.

"No claim for appointment, if so, made at any later stage on the basis of any ground by the candidate will be entertained by the department, in future."

This issues with the prior approval of the Competent Authority.
