ORDER

And whereas, the candidate had been issued offer of appointment vide Memorandum No. F.DE.4(49)/DRC/E-IV/PRT(42/21)/2023/2453 dated 29.08.2024 & Appointment order No. F.DE.4(49)/DRC/E-IV/PRT(42/21)/2023/1538-1548 dated 12.03.2025 with the direction to report to his respective place of posting latest by 11/04/2025 .

And whereas, the candidate had been issued an extension in date of joining vide order dated 30.04.2025 for a period of 25 days i.e. till 06/05/2025.

And whereas, the candidate was issued Final Opportunity vide letter no. DE.4(60)/DRC/E-IV/PARTFILE/(42/21)/PRT/2023/PT-2/V-I/03 dated 07.01.2026 with the direction to join his respective place of posting latest by 17.01.2026.

And whereas, the candidate has neither reported for his duties on respective place of posting nor requested any extension in joining till date to this office.

The above act on the part of the candidate is taken as refusal to join and it is presumed that the candidate is not interested in the appointment to the post of Assistant Teacher (Primary), under post code-42/21 in Level 7 Pay Matrix (Pre-revised Pay Scale - 9300-34800 with Grade Pay of Rs. 4200/-) plus usual allowances as admissible under the Rules.

Accordingly, the offer of appointment and appointment order issued to the candidate is hereby withdrawn and the candidature stands cancelled. No further correspondence in this regard will be entertained by this department, in future.
