CANCELLATION ORDER

Whereas, the Candidate namely Mr. NARENDRA KUMAR SINGH, Roll No. 111503500492, (Applied Category – EWS, Sub Category- PH VISUAL (VH) (Low Vision) was nominated for the post of TGT (Natural Science) - Male under post code-35/21 (as per Vacancy Advertisement No. 02/21) by the Selection Mechanism Authority i.e. DSSSB's Result Notice No.145/2021 dated 28.07.2022 and his Dossier received from DSSSB for further proceedings towards consideration of Appointment for aforesaid post.

And whereas, after the preliminary scrutiny of documents available in e-dossier, a Memorandum towards "Offer of Appointment" was issued 13.12.2022 to the aforesaid candidate with the directions to appear in person on the scheduled date, time and venue alongwith all the requisite documents for document verification. The candidate appeared for DV on scheduled date/time and, it was observed during the course of document verification conducted by the assigned Team that the aforesaid candidate has not produced some required documents alongwith an EWS Certificate issued before cutoff date (he did not possess any EWS Certificate issuing during financial year 2021-22 either issued before cutoff date or issued after cutoff date). Accordingly, a Deficiency Memo was issued vide letter no. No.F. DE.3 (29)//DRC/E-III/TGT/NATURAL SCIENCE/MALE/2022/909 on 19.12.2022 and his reply/ clarification(s) dated 03.01.2023/ 30.05.2024 alongwith an affidavit were not "upto the merit/ acceptable".

And whereas, it was mandatorily for a candidate of EWS category to submit the EWS certificate which validate as on or before Cutoff Date i.e. 04.07.2021 (year 2021-22) according to **para number 5(ii), 6(ii) towards availing 'Reservation Benefits' & 8(viii) of Vacancy Notice Advertisement No. 02/21** dated 12.05.2021 issued by DSSSB. It was specifically mentioned in the para number 6(ii) that: -

"Candidate who wish to be considered against reserved vacancies and/ or seek age relaxation, must be in possession of relevant certificates (EWS/SC/ST/OBC/NCL/PwD/Educational Experience etc.) issued by the competent/ notified authority (in prescribed format) on or before the cutoff date (closing date of advertisement) otherwise their claim for any category will not be entertained and **their applications will be considered against Un-reserved vacancies, if eligible otherwise**. The candidate has to select that particular category when applying online for the Post. No request for change of category will be entertained at any later stage."

And whereas, Mr. Narendra Kumar Singh was not in possession of a valid EWS certificate on or before cutoff date i.e. 04.07.2021 as per issued vacancy notice 02/21. The candidature of aforesaid candidate was treated not suitable in respect of validity of the certificate in the light of contained instructions on procedural aspects etc. i.e. crucial date w.r.t. **EWS certificates** according to Services Department latest O.M. dated 05-02-2024 whereby it was *clarified that the crucial date for submitting income and asset certificate by the candidate may be treated as the closing date for receipt of application for the post, except in cases where crucial date is fixed otherwise*. However, candidature of aforesaid candidate was not cancelled due to aforementioned ground being nominated under PWD category.

And whereas, candidature of Mr. Narendra Kumar Singh was considered under "UR-PH-VH (Low Vision)" instead of "EWS-PH-VH" by the Department according to the available provisions/conditions in para number 6(ii) of Vacancy Notice Advertisement No. 02/21 after taking opinion from the Services Department, Govt. of NCT of Delhi and he was provided appointment under PWD category vide Appointment Order No.: DE. 3(29)/(17)/DRC (E-III)/TGT (Natural Science)/Male/2022/551-561 dated 01.07.2025 (through offline mode) with the directions to report for duty at allocated place of posting latest by 31.07.2025.

And whereas, Mr. Narendra Kumar Singh (Emp. Id – 20250844) did not report for duty within stipulated period i.e. 31.07.2025 at his place of posting. Further, the candidate applied vide application dt.29.07.2025 for granting extension of joining time for a period of two month, and his request was considered by the Department and extension of time for joining was granted for a period of 60 days vide Extn. cum Appointment Order (through MIS) dated 26.09.2025 with the directions to report for duty latest by 30.09.2025 at GBSS – Gazipur (Sch. Id. 1002363). Further, after receiving applications dated 10.10.2025 & 20.11.2025 (through regd. email id) from the candidate, extension of time for joining the duties, was granted two more time by the Department including lastly upto 19.12.2025 vide Extension Order dated 12.12.2025 (vide Extension ID: 20094484), however, he did not join his duties within stipulated period. Thereafter, a "Final Opportunity Memo" number No.F. DE. 3(29)/(17)/DRC/E-III/TGT (N. Sc.)/Male/2022/123 was issued to the aforesaid candidate on 24.12.2025 with the directions to join his duties at assigned place of posting latest by 30.12.2025 and submit a copy of his Joining Order in DRC (E-III Branch), failing which his candidature for the aforesaid post will be cancelled without any further notice, however, he neither reported for duty at allotted place of posting by 30.12.2025 nor he has represented/ requested himself through any written application through any mode with the reason as well as grant of further extension of time for joining his duties, till date which shows that he is unwilling to join the duties for appointed post of TGT (Natural Science) - Male.

And whereas, the aforesaid candidate has already availed the opportunity of maximum period of extension i.e. 06 (Six) months towards joining the duties, as per prescribed norms.

Therefore, in view of the above facts and circumstances and since the Candidate has willfully chosen not to join the duties at concerned allotted school and thus the 'Provisional Appointment Order dated 01.07.2025' issued in favour of Mr. Narendra Kumar Singh (Emp ID: 20250844) (Posting ID. 20250087), is hereby withdrawn and his candidature for the post of TGT (Natural Science) – Male under post code 35/21, **stands cancelled** accordingly with the retrospective date of 'Memorandum: Offer of Appointment'.
