Consequent upon nomination through Delhi Subordinate Services Selection Board for the post of TGT HINDI (FEMALE) vide letter No. F.1(193)/DSSSB/P&P/2013/Pt-II/1/131418/2026 dated 19.01.2026 & Supplementary Result Notice No. 992 dated 12.01.2026 and in compliance of Ld. CAT order dated 21.03.2023 in O.A. No. 1497/2017 titled Ritu Rani Sharma Vs DSSSB & Anr, which was further upheld by the Hon'ble High Court of Delhi vide order dated 24.05.2024 in WP (c) No. 6802/2024 titled as DSSSB Vs. Amit Kuamr & ors. Further, with the prior approval of the Competent Authority, the following candidate is hereby appointed purely on Temporary and provisional basis, under the relaxation of FR. 10(4) for the post of TGT- Hindi (Female) under the post code 07/13 Adv no. 01/2013, in the pay Scale of Rs. 9300-34800 with Grade Pay of Rs. 4600 (Pre-revised) plus usual allowances as admissible under the Rules from time to time subject to usual terms and conditions given in the offer of appointment and accepted by her. The provisional appointment and draw of pay and allowance for a period not exceeding 2 months is subject to medical examination within 2 months from the date of provisional appointment under provisions of FR 10 and if the candidate is subsequently found medically unfit her services shall be terminated after the expiry of the period of 1 month from the date of communication to her of the findings of the medical officer/board, if no appeal for second medical examination is finally decided if such an appeal is made and accepted. On such appointment, she would be eligible for consequential benefits, i.e., seniority, fixation of pay from the date when their immediate junior in the relevant merit list has been appointed. The candidate is directed to report to her respective place of posting by 20.04.2026, failing which her appointment will be cancelled without any prior notice. (iii) Verification of recognition of institute/university and NCTE, from which the candidate has acquired his degree and on which they rely upon for the said post.
