2. 10th Class Mark Sheet and certificate showing Date of Birth.
3. 12th Class Mark Sheet and certificate.
4. Graduation Mark Sheet of every year and degree/provisional Certificate.
5. Post-Graduate Mark Sheet of Every Year and degree/provisional Certificate.
6. B.ed degree/provisional and mark sheet of every year.
7. SC/ST/OBC/EWS certificate (if applicable), issued by the Competent Authority. In case of OBC, the OBC Certificate should be issued by GNCT of Delhi.
8. Non-Creamy Layer Certificate (in case of OBC Candidate)
9. Disability Certificate (if Applicable).
10. Two Photographs.
11. Photo Identity Proof (Preferably Aadhar Card)
12. Address Proof.

Further, concerned HOSs may be directed to verify the abovementioned documents carefully within seven (07) working days positively and in case of discrepancy/variation of the data filled in the application form by the candidates vis-à-vis the original documents produced by the candidate, he/she shall not be joined

and her/his case shall be referred to E-V branch through the concerned District Office. After ensuring the genuinity of the documents/the applicants shall be joined in the school. In case of any clarification regarding Recruitment Rules for the concerned post, the HoS shall consult and seek advice of the Deputy Director of Education (E-II Branch). Moreover, the concerned HOS may be advised to contact the allocated guest teacher in his/her school for joining in the school and necessary status on MIS may be updated accordingly.

Concerned Heads of School (HoS's) are hereby directed to obtain an undertaking from the above applicants/ Guest Teachers confirming that they shall not claim salary, allowances, facilities, or any other benefits admissible to regular teachers, and that they shall not file any court cases regarding salary and regularization strictly in accordance with the term specified in the Engagement/offer letter.

Further, engagement of Guest Teachers is a stop gap arrangement and does not confer any right for permanent joining. The Guest Teacher shall be relieved once a permanent teacher joins the school. Further, No Claim for salary, allowance, facilities and other benefits accruing to the regular teachers shall be made and the Guest Teachers shall not file any court case regarding salary and regularization.
