**CIRCULAR**

**Sub:- Operationalization of the scheme "Mukhyamantri Khel Prothsahan Yojana" – Participation Support.**

With an aim to create a player-centric ecosystem to promote sports, the Government of NCT of Delhi has launched the "Mukhyamantri Khel Prothsahan Yojana" which envisions to support the sportspersons not just for their training requirement, but also help them participate in international tournaments besides rewarding their achievements in various sporting events by way of cash incentives.

Under this component the government will provide support to sportspersons for taking part in International Tournaments organised by Sports Federation/associations recognised by the International Olympic Committee and its affiliates, by reimbursing cost up to Rs. 2 Lakh for covering expenses related to travel, lodging & boarding and tournament fees.

Applications are invited from eligible & desirous sportspersons under the participation support of the Mukhyamantri Khel Prothsahan Yojana for the year 2024-25 as per details below: -

**1. CRITERIA FOR SELECTION:**

**i. Participation Support**

- a. The player should be a bonafide resident of Delhi for the last 3 years and should not be a recipient of the Training support for Elite Athletes.
- b. The international Tournament should have been conducted by the sports federations/associations recognized/affiliated by the International Olympic Committee.
- c. Support will be provided for only one Tournament in a Financial Year.

**2. AGE LIMIT: There will be no age limit.**

**3. GENERAL INFORMATION:**

- i. In case of any dispute or interpretation of the scheme, the decision of the Directorate of Education will be final and binding upon the player and coach.
- ii. The Directorate of Education, GNCT Delhi reserves the right to change/alter withdraw any/ all terms and conditions of the scheme.
- iii. If at any stage, a sportsperson receiving the assistance from the Government, is found guilty of age fraud or indulged in doping or getting the assistance from any other state/UT, then the assistance will be stopped with immediate effect. Recoveries will also be made of the assistance already provided.
- iv. Sportspersons applying for assistance from this scheme will furnish information about assistance received in kind or cash from any other source for the same purpose.

- v. The benefits taken by an outstanding sportsperson in the said scheme or from any other scheme of Government of NCT of Delhi will be adjusted/taken into consideration before releasing any assistance under the present scheme of Government of NCT of Delhi.
  - vi. The sportsperson shall submit an affidavit declaring that no financial or in-kind assistance has been received from any other source for the same purpose. In the event that any discrepancy is detected by this Directorate at any stage, the sportsperson shall be liable to refund the sanctioned amount to the Directorate within one week from the date of receipt of the notice.
4. Accordingly, desirous sportspersons may submit their applications for Participation Support for the tournaments/championships organized in the financial year 2024-25 i.e. tournament held on or after 01.04.2024 through OFFLINE module at Administration Branch, Chhatrasal Stadium, Model Town, Delhi 110009.

**Note: -**

1. The sportsperson shall submit a hard copy of Offline application form alongwith all relevant documents at Administration Branch, Chhatrasal Stadium, Model Town, Delhi 110009 by 07.05.2026 i.e Thursday.
2. **Non-submission of hardcopy alongwith the supporting documents by due date i.e. 07.05.2026 will render the applicant ineligible for the benefits under Mukhyamantri Khel Prothsahan Yojana.**
