Cancellation of Candidature for the post of TGT (Computer Science-39/22)

Whereas, **Sh. YOGESH KUMAR (Emp. ID 20250907), Cat.-UR** was nominated by the DSSSB in the waiting list for the post of TGT Computer Science under post code-39/22 and accordingly offer of appointment was issued to him.

Whereas, **Sh. YOGESH KUMAR (Emp. ID 20250907), Cat.-UR** was provisionally appointed for the post of TGT Computer Science under Post Code 39/22 vide appointment order no. F.No.DE.4(109)/DRC/E-IV/TGT(CS)(39/22)/2024/Partfile-I/4085-95 dated 22/09/2025 with posting ID-20250084 and was directed to join the duty in the allotted School latest by **20/10/2025**. After that a reminder was issued to him on dated 17/11/2025 to join his duties within 07 days. Thereafter, on his extension request, joining period was extended vide extension ID 20094483 to join his duties till 19/12/2025.

And whereas, **Sh. YOGESH KUMAR** has not reported at his place of posting by the stipulated time and sent an extension request through e-mail vide diary no. 793 dated 29/12/2025 to grant him further extension of 03 months. The said request for extension was placed before the competent authority for consideration, but the same could not be acceded to as per the guidelines of Services Department, GNCTD, vide circular number No.F.16(1)(d)/Misc./2018/S-iii/1769-1779 dated 18/11/2024 which are as follows:-

"02-Expediting the Process:- Extension in joining time should not be granted for procedural delays in sending reminders or final opportunities to the candidates Extensions, if any, must not exceed three months on an occasion from the date of issuance of Offer of Appointment, and should be reserved only in cases of Medical grounds or Technical resignation."

"05- Immediate Action in Case of Non-Joining:- The cases in which candidates fail to join even after lapse of extension period should be resolved without further delay. Departments should take prompt action in cancelling the offer of appointment."

As per the above guidelines, he has cumulatively granted an extension time of 90 days from date of issuance of appointment order, i.e. 22/09/2025, but he has not joined his duty till date.

Further, **Sh. YOGESH KUMAR (Emp. ID 20250907)** was also granted final opportunity vide letter dated **09/01/2026** with the prior approval of the competent authority to join his duties on his place of posting latest by **23/01/2026**.
