Consequent upon nomination through Delhi Subordinate Services Selection Board for the post of TGT-HINDI (FEMALE) vide letter No.F.1 (193)/DSSSB/ P&P/2013/3395-98 dated 22.09.2025 & Supplementary Result Notice No. 985 dated 22.08.2025 and in compliance of Ld. CAT order dated 04.09.2024 in O.A. No. 2316/2016 titled Muneshi Bai Meena Vs DSSSB & Anr, which was further upheld by the Hon'ble High Court of Delhi vide order dated 28.07.2025 in WP (c) No. 7379/2025.
